SITUATION

I am in the middle of the “divorce” process in DeKalb County Superior Court, Decatur, Georgia (the lesbian capitol of the world). I believe divorce is wrong. I am being pushed through the court system without an opportunity to “contest” this divorce until I went into the courtroom of a new judge who is new to

When I was in the courtroom though, a clerk comes in who has nothing to do with the case, but he is there passing notes to the bailiff and clerks. Why? Believe what I am going to tell you here, though you may find it difficult to believe, it is true. And this is being allowed across this great nation by elected officials, judges, courts, social service agencies and state systems.

PUBLISHED DIVORCE

This is what is going on in America—women are being allowed to post their divorce request via the newspaper or some publication without the knowledge of the spouse. Once 45-60 days have expired, the “uncontested” divorce is processed with the husband finding out about his divorce when the Deputy Sheriff comes by to deliver the divorce papers. You must ask yourself this question among many: How did the Deputy Sheriff know how to find the person?

Christians need to stand up and do something about this issue—take issue with it—take up protest against this before it happens to you. Hollywood is not middle America; so stop emulating them. They care nothing about the family; only about themselves and their "bank" and their "bling-bling."

The Holy Spirit has directed me to stand in the DeKalb County Courtroom and say, "Divorce is wrong and not acceptable in the sight of the LORD. If families are heading towards divorce, then there needs to be a system in place to help heal these families to give them an opportunity to survive intact and not live in adultery and division."
